Rules of procedure

1) Admission and residence conditions

To be admitted to enter, settle or stay on a , you must have been authorized by the manager or his representative. It is the manager's duty to ensure that the campsite is kept in good order and that the present rules and regulations are applied.

Staying on the campsite implies acceptance of the provisions of the present regulations and a commitment to comply with them. No one may take up residence on the campsite.

2) Police formalities

Unaccompanied minors will only be admitted with written authorization from their parents.

Pursuant to article R. 611-35 of the Code de l'Entrée et du Séjour des Etrangers et du Droit d'Asile (French code on the entry and residence of foreign nationals and the right to asylum), the manager is required to have foreign customers complete and sign an individual police form on arrival. This form must include the following information

1° Full name ;

2° Date and place of birth; 3°

Nationality;

4° habitual place of residence.

Children under the age of 15 may appear on the card of one of the parents.

3) Installation

The outdoor accommodation and related equipment must be installed on the site indicated in accordance with the instructions given by the manager or his representative.

4) Reception desk

Open in July & August from 8:30am to 12:00pm and from 3:00pm to 7:00pm, the rest of the year from 9:00am to 12:00pm and from 3:00pm to 6:00pm, weekly closing on Sunday afternoon.

At the reception desk, you'll find all the information you need about campground's services, refreshment facilities, sports facilities, local tourist attractions and other useful addresses.

5) Display

These rules and regulations are posted at the entrance to the campsite and at the desk. They are given to any customer who requests them. In the case of classified campsites, the classification category with the mention "tourism" or "leisure" and the number of tourism or leisure pitches are displayed. The prices of the various services are communicated to customers in accordance with the conditions laid down by order of the Minister for Consumer Affairs, and can be consulted at reception.

6) Departure terms and fees

Fees are payable at the reception desk. Fees are posted at the entrance to the campsite and at the reception desk. They are due according to the rental contract signed by both parties. The balance must be paid on the day of arrival. Customers are asked to inform the reception desk of their departure the day before.

7) Noise and silence

Guests are kindly requested to avoid any noise or discussion that might disturb their neighbors. Sound equipment must be adjusted accordingly. Visit door and trunk locks should be as unobtrusive as possible. Between 10 p.. and 7 a.m., any infringement these provisions will be considered as night-time disturbance. It is forbidden to be in an obvious state of drunkenness on the campsite premises.

8) Visitors

A visitor is a person who visits a camper on his/her pitch between 10.00 am and 7.00 pm. Visitors may be admitted to the campsite (after authorization from the manager) under the responsibility of the campers receiving them. They must present <u>themselves personally</u> at the reception desk with a piece of identification. Visitors are not allowed to bring their own vehicles onto the campsite; an outside parking area is provided for this purpose. They do not have access to the swimming pool, nor to the various services offered by the campsite. The number of visitors per pitch must not exceed four.

9) Guests

A guest is invited to stay on a camper's pitch by the camper. He or she will sleep on the pitch in the facilities already in place. Guests may use the campsite facilities, as well as all services (swimming pool). They are admitted to the campsite (after authorization by the manager) under the responsibility of the campers who receive them. They must present themselves in person at the reception desk, showing proof of identity. number of guests and campers per pitch may not exceed six. Guests may enter the campsite with their vehicle and park on the pitch, subject to a limit of one vehicle per pitch. A fee must be paid by the camper.

10) Vehicle traffic and parking

Inside the , vehicles must not exceed a speed limit of 10km/h. Traffic is authorized from 7am to 11pm.

Only vehicles belonging to campers staying at the campsite may circulate in the campsite. Parking is strictly forbidden on pitches usually occupied by accommodation unless a parking space has been provided for this purpose. Parking must not impede traffic or prevent new arrivals from settling in.

11) Maintenance and appearance of installations Everyone is required to refrain from any action that could damage the cleanliness, hygiene and appearance of the campsite and its facilities, particularly the sanitary facilities. It is forbidden to dispose of wastewater on the ground or in gutters.

Campers must empty wastewater into the facilities provided. Household waste, garbage of all and paper must be disposed of in the garbage cans.

Washing is strictly forbidden outside the bins provided for this purpose. Laundry may be hung in the communal dryer. However, it is tolerated until 10 a.m. in the vicinity of the accommodation, provided that it is discreet and does not disturb the neighbors. It must never be done from trees. Plantations and floral decorations must be respected. It is forbidden hammer nails into trees, cut branches or make plantations. It is forbidden to demarcate the site of an installation by personal means, or to dig into the ground. Any damage to vegetation, fences, grounds or campsite facilities will be charged to the person responsible. The site used during the stay must be maintained in the condition in which the camper found it on arrival. It is forbidden to deprive caravans and hlls, whatever their size, of their means of mobility (towbar, wheels, etc.), or to erect awnings whose context and fixity would make them subject to planning permission.

12) Security

a) Fire.

Open fires (wood, coal, etc.) are strictly forbidden. Barbecues are permitted. Stoves must be kept in good working order and not used in dangerous conditions.

In the event of fire, notify management immediately. Fire extinguishers are available if necessary. A first-aid is available at the reception desk.

b) Vol.

The management is responsible for items left at the office and has a general obligation to monitor the . Campers are responsible for their own facilities, and must report the presence of any suspicious persons to the manager. Customers are asked to take the usual precautions to safeguard their equipment.

13) Games

The management accepts no responsibility for any accidents that may occur to children, who must always be supervised by their parents (on the playgrounds, shutter area, petanque area, etc., as in the rest of the campsite).

No violent or disruptive games may be played in the vicinity of the facilities. The big top may not be used for boisterous games.

Children must always be supervised by their parents.

14) Swimming pool

THE POOL IS OPEN IN JULY AND AUGUST from 11am to 7:45pm.

Shoes and clothing are not permitted in pool area. They must remain outside.

The foot bath is compulsory. Bathers must shower before entering the pool.

Swimsuits must be worn. Long suits, Bermuda shorts and Tshirts are forbidden. Boxer shorts are accepted. Users must remain correctly and decently dressed. Any act or behavior likely to offend decency, public decency, the peace and quiet of bathers, or the good order and cleanliness of the establishment, is strictly forbidden. It will be punished by immediate dismissal from the pool. Only young children who are "clean" or equipped with special swim are allowed to swim.

It is forbidden to block the gate to free access to the pool. Swimmers must not use the foot baths for purposes other than those for which they are designed.

It's forbidden to smoke, chew gum, spit, eat or drink on the beaches.

Animals may not brought onto the premises. No running, pushing or diving on the beaches.

It is forbidden to urinate in the water. Freediving is forbidden. Access to the

The swimming pool is forbidden to people with suspicious skin lesions or any other ailment who are not in possession of a certificate of non-contagion.

Access is strictly forbidden outside opening hours. Failure to comply with these rules will result in expulsion.

Pool depth: 1.45 m Water level: 1.35 m - Maximum instantaneous number of visitors: 25 Maximum instantaneous number of bathers: 20 The management reserves the right to close the pool during opening hours to deal with any technical problems. SWIMMING IS UNSUPERVISED AND THE MANAGEMENT ACCEPTS NO RESPONSIBILITY FOR ACCIDENTS. ALL CHILDREN MUST BE ACCOMPANIED BY AN ADULT.

15) Dead garage

Unoccupied equipment may only be left on the site with the agreement of the management, and only on the pitch indicated. There is a charge for this service.

16) Internet

A free wifi connection is available on part of the campsite. If the wifi network is cut off after 6:00 p.m., it will not be restored before 10:00 a.m. the following day. No discount will be granted in the event of a connection malfunction.

17) Image rights

You authorize the campsite to use on any medium, photos or videos of you or your children that may be taken during your stay for the advertising needs of the campsite. Please let us know if you do not wish to appear in these media.

18) Display

These rules and regulations are posted at the entrance to the and at the reception desk. They will be given to customers on request.

19) Pets: Pets are not allowed in July and August. Outside these two months, they are accepted only on pitches 1 to 7 (except 1st and 2nd category dogs), for a fee payable the time of booking. Where dogs are allowed, they must be kept on a leash at all times. Dogs are not allowed near the swimming pool, in the snack bar or in the sanitary facilities. Vaccination certificates for dogs and cats must be up to date.

20) Electric car

It is forbidden to connect electric cars to rental units or camping terminals.

21) Infringement of internal regulations

In the event of a resident disrupting the stay of other users, or failing to comply with the provisions of these rules and regulations, the manager or his representative may, orally or in writing if he deems it necessary, give formal notice to the resident to cease the disturbance.

In the event serious or repeated breaches of the rules and regulations, and after formal notice to , the manager may terminate the contract.

In the event of criminal offence, the manager may call in the police.
